# '51% off your first 4 weeks' Promotion Terms and Conditions

#### 1. Interpretation and precedence

#### 1.1 Definitions

In this Agreement, the following definitions apply:

**Applicant** means a person who becomes a WSAC member during the Promotion Period

**Australian Consumer Law** means Schedule 2 of the *Competition and Consumer Act 2010* (Cth).

**Council** means the Rural City of Wangaratta.

**Promotion** means the '51% off for 4 weeks' Promotion

**Promotion period** means the period commencing on Sunday June 1 to Monday 30 June 2025

- d) all monetary amounts are expressed in Australian Dollars (\$AUD); and
- e) parties must perform their obligations on the dates and times fixed by reference to Wangaratta, Victoria.
